- A. Bus dismissal times will improve soon - be patient - the town and the District are working on changing the timing of the traffic lights at the High School in order to facilitate a more efficient dismissal.
- B. Problems with Promethean boards are being addressed - again, be patient - The District is working on getting some District personnel certified to work on the boards so that warranty won't be voided. No further installations will take place until present problems are taken care of.
